- A 5:1 taper from sidewalk edge to ground elevation needs to be provided (If applicable).

- 5. **Keyed Note 29:** Explain why are you using COA std Dwg 2432?
- 6. A sidewalk easement will be needed for sidewalk located outside of public ROW
- 7. Motorcycle parking spaces: shall be designated by its own conspicuously posted upright sign, either free-standing or wall mounted per the zoning code. **Provide sign face** detail.
- 8. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the ADA parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.

- 9. Please provide a letter of response for all comments given.
- 10. Traffic Studies: See the Traffic Impact Study (TIS) thresholds. In general, a minimum combination of 100 vehicles entering and exiting in the peak hour warrants a Traffic Impact Study. Visit with Traffic Engineer for determination, and fill out a TIS Form that
