- 5. Wastes throughout the site not in an acceptable container.
- 6. The waste container was not covered/no ability to cover.
- 7. Wash-out on the ground/not in an acceptable container.



Required mitigation:

- 1. Provide vehicle tracking control at locations where vehicles exit the site.
- 2. Remove sediment from Bosque Plaza Lane and La Orilla Rd.
- 3. Remove waste from pond and pond outfall.
- 4. Place wastes throughout the site in an acceptable container.
- 5. Provide a cover for the waste container.

- 6. Remove wash-out from the ground.
- 7. Provide an acceptable wash-out facility and have workers use it.
- 8. Remove sealer material from the ground and prevent sealers/paints/similar materials from contacting the ground.

Per the previous Violation letter, the City is assessing a fine of \$8000. This fine is for sixteen days. It is to be paid within 30 days and/or prior to Certificate of Occupancy, whichever comes first.

Additional days may be added if the violation is not mitigated within ten days. In addition, your non-compliance is being reported to the New Mexico Environment Department, Surface Water Quality Bureau to aid in the determination if this issue is to be forwarded to the EPA.
