Provide a brief summary of the basis for criterion selection listed above (the necessary content for a supportive basis statement is provided under the criterion you selected.):

The USFWS Species Report and IPaC Critical Habitat Map indicate there are no critical habitats in the action area. The nearest T&E species is approximately 0.95 miles southeast of the project and resides in the Rio Grande. The project discharge is not likely to adversely impact the habitat or species as the initial grading will construct a stormwater retention pond to which the stormwater runoff will flow. The site is not likely to experience a storm event resulting in a volume of precipitation that would cause sediment to overflow from the pond and travel via the COA MS4 system to the nearby irrigation canal and then the habitat. The irrigation canal is not active year round.
