Our neighborhood HOA Board would like to find out who we need to talk to in order to report an on-going flooding issue, and I wonder if you could help me in this regard by telling me who I need to contact.

Our neighborhood is called Las Casitas del Rio II. Located on Deergrass Circle on the West side (Coors and Montano area), it is off of Winterhaven where the problem lies. Every time it rains, the West side of Winterhaven floods heavily and the drainage in place cannot keep up. Our concern is that in the event of a long heavy rain, the water accumulating will get over the very small elevation created by the curve of the street and come running eastward into Deergrass circle, inevitably flooding the lower homes that are along the Bosque.

We very much feel that the drainage installed is inadequate and would like to see if it can be fixed.
