

Curtis,

The scope of this project includes the construction of a new Generator enclosure at the west end of the existing parking lot of this property. The generator pad will require installation of some fill to build up the pad and this earthwork will extend into the drainage pond on the west side of the site. The enclosed drawing is a portion of the site plan indicating the extent of the work required for this pad installation. The volume of dirt required to build up the pad that extends into the pond is approximately 792 CF. This volume will reduce the water storage capacity of the west pond by 2.7% of it's original capacity. The site has 2 ponds and this earthwork will reduce the entire pond storage on the site by approximately 1.1% of the original 70,762 CF of water storage capacity. In a maximum storm event this reduced volume represents a water level increase of 0.03 feet, or 3/8 inch. Therefore, the relative impact on the pond capacity on the site is minimal and the earthwork will have no significant effect on the drainage runoff storage capacity on site.
