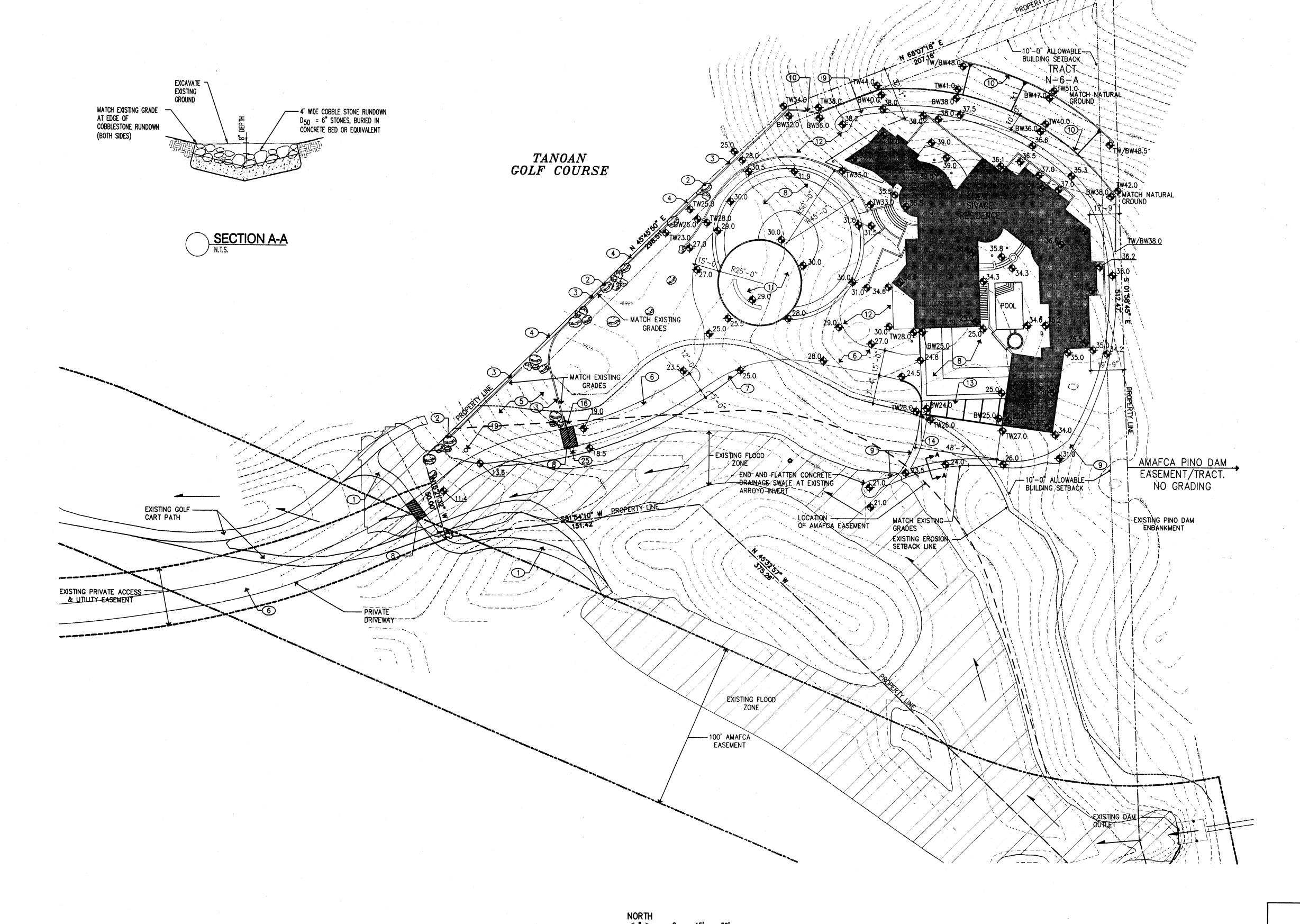

GENERAL NOTES

BE MADE.

- 1. CONTRACTOR SHALL OBTAIN AND ABIDE BY A TOPSOIL DISTURBANCE PERMIT FROM THE CITY OF ALBUQUERQUE (COA). THE COST FOR REQUIRED CONSTRUCTION DUST AND EROSION CONTROL MEASURES SHALL
- BE INCIDENTAL TO THE PROJECT COST. 2. EARTH SLOPES SHALL NOT EXCEED 3 HORIZONTAL TO 1 VERTICAL
- UNLESS SHOWN OTHERWISE. 3. A DISPOSAL SITE FOR ALL EXCESS EXCAVATION MATERIAL, AND UNSUITABLE MATERIAL SHALL BE OBTAINED BY THE CONTRACTOR IN COMPLIANCE WITH APPLICABLE ENVIRONMENTAL REGULATIONS AND APPROVED BY THE OBSERVER. ALL COSTS INCURRED IN OBTAINING A DISPOSAL SITE AND HAUL THERETO SHALL BE CONSIDERED INCIDENTAL TO THE PROJECT AND NO SEPARATE MEASUREMENT OR PAYMENT SHALL
- 4. ALL WORK DETAILED ON THESE PLANS AND PERFORMED UNDER THIS CONTRACT SHALL BE CONSTRUCTED IN ACCORDANCE WITH THE COA PUBLIC WORKS SPECIFICATIONS AND/OR THE PROJECT GEOTECHNICAL
- 5. PRIOR TO CONSTRUCTION, THE CONTRACTOR SHALL FIELD VERIFY THE HORIZONTAL AND VERTICAL LOCATIONS OF ALL POTENTIAL OBSTRUCTIONS. SHOULD A CONFLICT EXIST, THE CONTRACTOR SHALL NOTIFY THE
- CONSTRUCTION OBSERVER OR ARCHITECT. 6. TWO (2) WORKING DAYS PRIOR TO ANY EXCAVATION. THE CONTRACTOR SHALL CONTACT A LINE LOCATING SERVICE FOR LOCATION OF EXISTING
- CONTRACTOR SHALL INSTALL ALL UTILITY LINES IN ACCORDANCE WITH COA STANDARDS AND APPLICABLE REGULATIONS. CONTRACTOR SHALL VERIFY UTILITY METER LOCATIONS WITH UTILITY COMPANY AND INSTALL PER UTILITY COMPANY REQUIREMENTS.
- CONTRACTOR IS RESPONSIBLE FOR PROTECTING ALL EXISTING UTILITY LINES WITHIN THE CONSTRUCTION AREA. ANY DAMAGE TO EXISTING FACILITIES CAUSED BY CONSTRUCTION ACTIVITY SHALL BE REPAIRED OR REPLACED AT THE CONTRACTOR'S EXPENSE. CONSTRUCTION ACTIVITY SHALL BE LIMITED TO PROJECT LIMITS. ANY DAMAGE TO ADJACENT PROPERTIES RESULTING FROM THE CONSTRUCTION PROCESS SHALL BE

- 9. OVERNIGHT AND DAYTIME PARKING OR STORAGE OF CONSTRUCTION EQUIPMENT SHALL BE LOCATED WITHIN THE WORK ZONE. THE CONTRACTOR SHALL NOT STORE ANY EQUIPMENT OR MATERIAL WITHIN THE PUBLIC RIGHT-OF-WAY OR EXISTING STREETS.
- 10. CONTRACTOR SHALL MINIMIZE NOISE AND DISTURBANCE TO GOLFERS, AND SHALL NOT BLOCK GOLF CART PATHS WITHOUT PROVIDING SAFE DETOURS ACCEPTABLE TO THE GOLF COURSE MAINTENANCE STAFF.

11. CONTRACTOR SHALL STAKE AND PROVIDE TEMPORARY FENCING ON THE EAST PROPERTY LINE (COMMON WITH THE PINO DAM/AMAFCA EASEMENT). NO GRADING OR OTHER DISTURBANCE

OF SERVICE ENTRANCES AT BUILDING.
