In order to provide fair and effective enforcement of the City Policies, and prevent any further damage to the adjacent property. We are requesting that a revised drainage plan be submitted addressing the corrective measures necessary to bring the site into compliance.

Please advise our office within 15-days from the above date as to what will be done.
