Based on the certification provided in your submittal received 2/11/2016, the above referenced is approved for a 4-day Temporary Release of Occupancy by Hydrology. However, before a permanent CO can be accepted the following comments must be addressed.

PO Box 1293

Albuquerque

- Submit approved grading and drainage drawing with engineer stamp date of 8-26-15.
- The sidewalk culvert must be completed. Until it is complete it must remain barricaded with "Sidewalk Closed" signs on both sides starting at each entrance to the site. The bottom of water harvest on this pond needs to be approximately 3'-3" below TOC.

New Mexico 87103

- The pond that diverts to the above mention culvert needs to be graded to flow into the culvert.
- The bottom of water harvest on the NW corner needs to be approximately 3'-3" below TOC.

- The 3' curb cut is missing from this water harvest area.
- The bottom of water harvest on the SE corner needs to be approximately 2'-3" below TOC.
- The bottom of water harvest on the east side needs to be approximately 2'3" below TOC.

An inspection by our office will need to take place after these corrects are made.


