Provide a brief summary of the basis for criterion selection listed above (the necessary content for a supportive basis statement is provided under the criterion you selected.):

The USFWS Species Report and IPaC Critical Habitat Map indicate the project is outside any critical habitats. The nearest T&E species is approximately 1.7 miles west in the Rio Grande. The project is not likely to adversely impact the habitat or species because there is no grade and the project area is encircled by a retaining wall, limiting discharge offsite. Additionally, the project discharge may intersect with various irrigation canals which run parallel to the Rio Grande. These intersections and conveyances increase the travel distance between the project and habitat area.
