Gary, yes, the access aisle is flush with the sidewalk. We could install a wheel stop at the HCP parking space, but my only concern is that as you know, this parking space is seldom occupied and it has been my experience that wheel stops become a tripping hazard. The sidewalk and ramp are 8' wide, so even with a 2' overhang the ramp is 6' wide. I had this discussion with Raquel when we submitted the TCL and we agreed this was an acceptable configuration.
