



**Dear Mr. Aguirre:**

**Based on the information included in the submittal referenced above, City Hydrology has the following comments that must be addressed before Building Permit approval:**

- 1. The legal description does not match Zone Atlas G-13. Is a plat proposed? Indicate property lines.**
- 2. Conceptual Grading & Drainage Plan is required for the entire school site.**
- 3. Grading & Drainage Plan for Soccer Fields must identify offsite flows and verify downstream capacity. Since the Fields appear to be in a depression where ponding has historically occurred, treat this area as if it were a floodplain and maintain the existing retention volume.**
