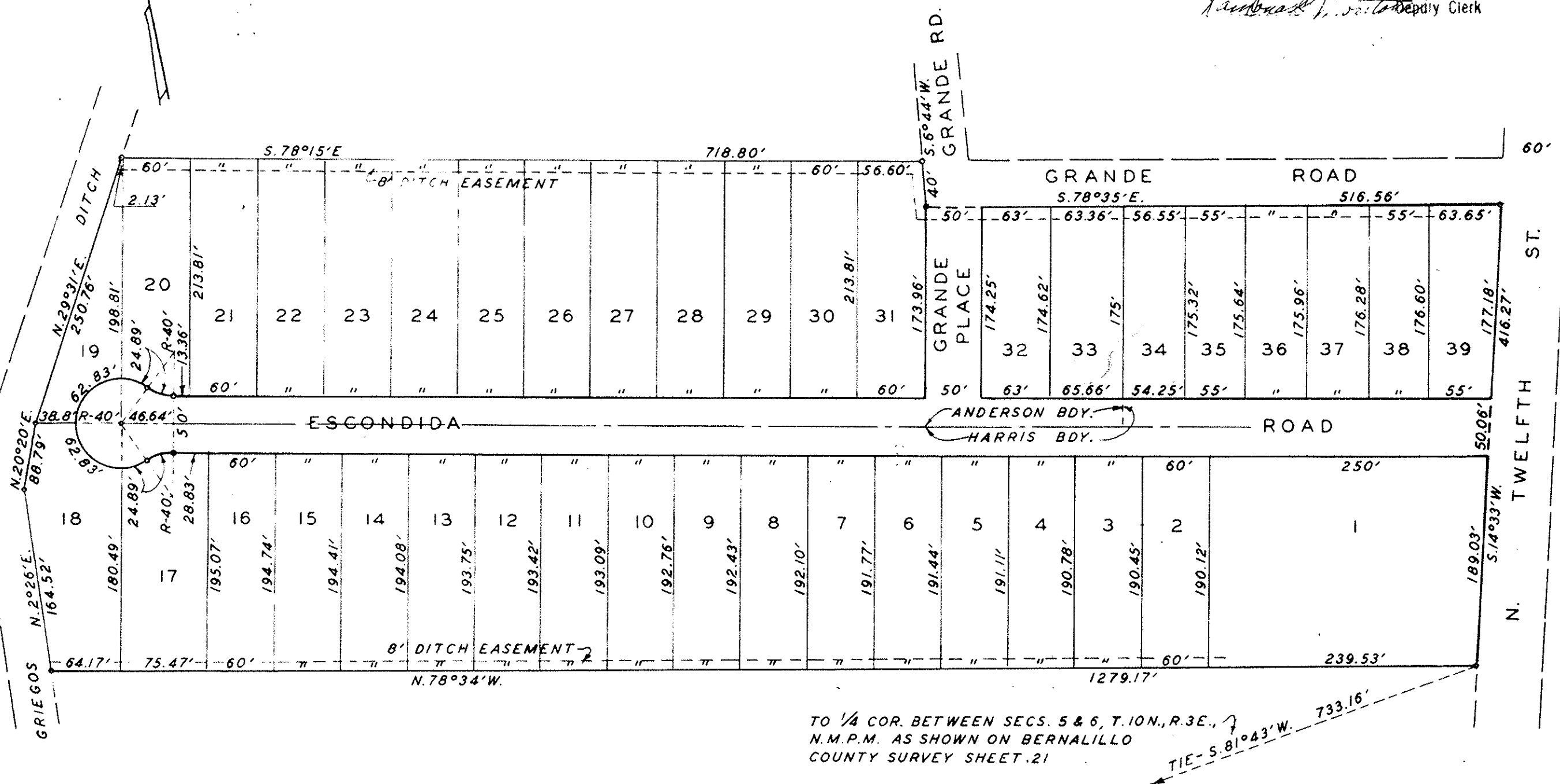

The foregoing subdivision of that certain tract of land situate in School District 22, Bernalillo County, New Mexico, and more particularly described as follows: Beginning at the Southeast corner No. 1, a point on the westerly line of North Twelfth Street, whence the Quarter Corner on the line between Sections 5 and 6, Township 10 North, Range 3 East, N. L. R. L., as shown on Bernalillo County survey sheet No. 21, bears S. 81° 43' W., 733.16 feet distant; running thence N. 78° 34' W., 1279.17 feet to the Southwest corner No. 2, a point on the easterly right of way line of Griegos Ditch; thence along said ditch line as follows: N. 20° 26' E., 164.52 feet to corner No. 3; N. 20° 26' E., 88.79 feet to corner No. 4; N. 29° 31' E., 250.76 feet to the Northwest corner No. 5; thence leaving said ditch and running S. 78° 15' E., 718.80 feet to corner No. 6, a point on the westerly line of Grande Road; thence along the westerly and northerly line of said Grande Road as follows: S. 8° 44' W., 40 feet to corner No. 7; S. 78° 35' E., 516.56 feet to intersect with the westerly line of North Twelfth Street and the Northeast corner No. 8; thence S. 14° 33' W., 416.27 feet along said Street line to the place of beginning, and surveyed and subdivided as the same appears hereon, comprising Lots numbered 1 to 39, of ANDERSON-HARRIS ADDITION, ALBUQUERQUE, BERNALILLO COUNTY, NEW MEXICO, is with the free consent and in accordance with the desires of the undersigned owners and proprietors thereof.
