- 1. The Engineer's certifying language will need to be per the DPM, see attached sample.
- 2. All pond volumes require certification. Please provide the north and south pond volume.
- 3. After a recent site visit, it appears some asphaltic material was placed in the south pond. The fill will affect the volume and may cause flows to leave the site to the east and west. The approved plan calls for 690 cf of storage. Please clarify the grades in this area.
- 4. Additional certified spot elevations are required for permanent certificate of occupancy acceptance by hydrology.
- 5. The as-built plan should reflect as constructed conditions.
  - a. The landscape area adjacent to the entrance drive was not built.
  - b. Plan should note all walls that are not constructed.
