This email is being sent in lieu of an attached comment letter in order to expedite the response for initial reviews. Responses to comments should continue to be included in the re-submittal. A reply to this email with responses to comments will not be considered a re-submittal. Based upon information provided in your submittal received 7-18-2016, the above-referenced Grading and Drainage plan cannot be approved for Building Permit until the following comments are addressed: It is not clear what the limits of the improvements are, provide hatching for new asphalt and paved surfaces within the site. Not completely Clear, but negligible impact to 141d. a. Clarify what the existing parking lot/access surface is (gravel, paving). It is not clear from aerial photos. Provide elevations and build notes for new paving and concrete. There appears to be a new concrete parking area proposed. Existing Clarify the extent of the improvements within the Right of Way. The sidewalk and driveways are hatched as if they are existing, but it appears that some are actually proposed. The plan should include build notes and elevation data for the contractor to follow, particularly since part of the sidewalk is replacing a sloped, paved, continuous driveway. a. New sidewalk in the right of way will need to reference the City's revised 2405A and B Standard Drawings. Provide top and bottom elevations of the first flush ponds, and a conceptual cross section. The line work suggests a drop off at the edge of the ponds. They me just going to be depressions It is not clear that any flow would reach the westernmost first flush pond. in the parking 6. Show the direction of the roof drainage, to ensure that it is planned to discharge within the property. Parking and sidewalk improvements will need approval from Transportation Development (through a TCL submittal) Additional comments may be generated based on additional information that would be provided to address comments 1 through 4.

Based on your comments dated August 1, 2016 for the above referenced site, attached please find two copies of revised site plan. SBS Construction and Engineering, LLC after meeting with you has addressed the comments and are as follow:

- 1) The drive aisle are existing and dimensions are shown on the plan. I did show you the pictures of the driveways in the meeting that we had.
- 2) The drive aisle are existing. The were built per City Std. DWG 2425. There are no radiuses.
- 3) There are existing pedestrian walkways along Stanford. Per your request at the meeting we had, to show a 4' wide pedestrian walkway at the north connecting front sidewalk to the back of the building, see note 19 on key notes.
- 4) We have modified this pathway to 6' wide, see key note 10. We have also relocated the handicap parking to the west as per instruction in the meeting.
- 5) The existing 6' sidewalk follows the existing sidewalk along Stanford and do not need to be relocated.
- 6) The location of existing trash enclosure is shown on the plans and as per our meeting you said we do not need to get refuse approval.
- 7) All the sidewalks and driveways are existing and there no proposed construction for this project.
- 8) There are no construction proposed.
- 9) We have look at the DPM. We are not proposing any new construction.
- 10) We are not proposing any new construction for this site.

Based upon the information provided in your submittal received 07-29-16, the above referenced plan cannot be approved for Building Permit until the following comments are addressed:

1. Show all drive aisle widths and radii. (all out ou way


- 2. List radii for all curves shown; for passenger vehicles, the minimum end island radius is 15 ft. Landscape island radius for delivery trucks, fire trucks, etc. is 25 ft. or larger.
- 3. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the public sidewalk and handicapped parking to the building entrances. Please clearly show this pathway and provide details.
- 4. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the HC parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.
- 5. All sidewalks along streets should be placed at the property line.
- 6. Service vehicle and/or refuse vehicle maneuvering must be contained on-site; provide a copy of refuse approval.
- 7. Please specify the City Standard Drawing Number when applicable to all curb cuts and ramps.
- 8. Work within the public right of way requires a work order with DRC approved plans. Please add a note on the plan stating "All improvements located in the Right of Way must be included on the work order."
- See Chapter 23, Section 6 of the City of Albuquerque Development Process Manual, for appropriate drive pad widths.
- 10. All broken or cracked sidewalk must be replaced with sidewalk and curb & gutter. A build note must be provided referring to the appropriate City Standard drawing.


