### Curtis,

Yes, see enclosed plat. We already spoke to both Shahab at the city and Lynn at AMAFCA concerning these lots. The City and AMAFCA indicated that they would approve our permits because:

- Lots 1 3 are protected by the existing infrastructure (the existing 3 90" culverts, the existing wing walls and drop structure); see the enclosed exhibit...
- Lots 1 − 3 are models and Shahab was comfortable approving us for building permit for model lots
- We are in the process of submitting the LOMR-F for the lots along the arroyo (lots 3-26)
  - We will have the LOMR-F approved prior to requesting a CO for any home w/in the floodplain
    - Thus the city can withhold CO on any home
- Notice that AMAFCA allowed us to vacate their Temporary Drainage Easement (see enclosed recorded plat noting this vacation).

Also, if you look at your exhibit its fairly clear that the first three lots are not affected much by the existing floodplain and it didn't take into account the culverts at TP or the wing walls.

Let me know if you continue to have a concern or not and if we will have issues requesting a permit for our models.
