





The TCL submittal received 7-12-04 is approved for Building Permit. The plan is stamped and signed as approved. A copy of this plan will be needed for each of the building permit plans. Please keep the original to be used for certification of the site for final C.O. for Transportation.

If a temporary CO is needed, a copy of the original TCL that was stamped as approved by the City will be needed. Dear Mr. Lewis:

Based on the information provided on your June 22, 1995 submittal, listed are some concerns that will need to be addressed prior to final approval:

- 1. The proposed disposal of the existing type "C" inlet must be replaced with the same type and must be coordinated through D.R.C.
  - 2. Provisions must be provided to outlet the roof drainage from the car wash onto the asphalt and eventually down towards the proposed inlet. Run-off can not pond within the landscape area.
  - 3. See attached comments by Loren Meinz.
