The corresponding NOI was certified on 6/1/2021 and authorized on 6/15/2021. The corresponding NOI selected Criterion A on the basis that the USFWS Species Report and IPaC Critical Habitat Map indicate there are no T&E species or critical habitats in the action area. The nearest critical habitat is approximately 2.42 miles west of the project, point-to-point. However, it is not likely the species will be adversely impacted as the project discharges to the COA MS4 system and travels through the COA stormwater conveyances and irrigation canals that run parallel to the habitat for approximately seven miles before the San Jose Canal meets the COA wastewater treatment plant's outfall to the Rio Grande. The COA conveyances are soft-bottomed canals/ditches and largely dry outside of the irrigation season.
