Dear Mr. Wooten,

Based upon the information provided in your submittal received 04-12-23, the above referenced plan cannot be approved for Building Permit until the following comments are addressed:

- 1. List the number of parking spaces required by the IDO as well as the proposed number of parking spaces including bicycle and motorcycle parking.
- 2. Identify all existing access easements and rights of way width dimensions.
 - 3. Identify the right of way width, medians, curb cuts, and street widths on McKnight Ave.
- 4. Please update both site accesses to current ADA standard and reference city standard.
 - 5. Site plan shows a property line in the middle of the site, but GIS and IDO maps show it's one whole site. Please clarify why the site plan has a property line in the middle of the site.
 - 6. Please list the width and length for all existing and proposed parking spaces. Some dimensions are not shown.

7. The ADA access aisles shall have the words **"NO PARKING"** in capital letters, each of which shall be at least one foot high and at least two inches wide, placed at the rear of the parking space so as to be close to where an adjacent vehicle's rear tire would be placed. (66-1-4.1. B NMSA 1978)

- 8. ADA curb ramps at the corner of Edith Blvd. & Hannett Ave. and Edith Blvd. & McKnight Ave. must be updated to current standards and have truncated domes installed.
- 9. Motorcycle parking spaces shall be designated by its own conspicuously posted upright sign, either free-standing or wall mounted per the zoning code.
 - 10. The pavement marking "MC" should be shown in the opposite direction for motorcycles entering the parking space.
- 11. Keynote 12: please clearly show the Bike Racks on the site plan and provide details.
- 12. All bicycle racks shall be designed according to the following guidelines:
 - a. The rack shall be a minimum 30 inches tall and 18 inches wide.
 - b. The bicycle frame shall be supported horizontally at two or more places. Comb/toaster racks are not allowed.

- c. The rack shall be designed to support the bicycle in an upright position. See the IDO for additional information.
- d. The rack allows varying bicycle frame sizes and styles to be attached.
- e. The user is not required to lift the bicycle onto the bicycle rack.
- f. Each bicycle parking space is accessible without moving another bicycle.
- 13. Bicycle racks shall be sturdy and anchored to a concrete pad.
- 14. A 1-foot clear zone around the bicycle parking stall shall be provided.
- 15. Bicycle parking spaces shall be at least 6 feet long and 2 feet wide.
- 16. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the ADA parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.
- 17. ADA accessible pedestrian pathway should not be placed behind parking space or adjacent to a vehicular way. Vehicle and pedestrian/wheel chair conflicts should be avoided as much as possible.

 18. Refuse vehicle maneuvering shall be contained on-site. The refuse vehicle shall not back into the public right of way.; provide a copy of refuse approval.
 - 19. Provide a copy of Fire Marshal approval.
- Albuquerque 20. Show the clear sight triangle and add the following note to the plan: "Landscaping and signage will not interfere with clear sight requirements. Therefore, signs, walls, trees, and shrubbery between 3 and 8 feet tall (as measured from the gutter pan) will not be acceptable in the clear sight triangle.
 - 21. Please specify the City Standard Drawing Number when applicable.
 - 22. Add a note stating "All broken or cracked sidewalk must be replaced with sidewalk and curb & gutter." A build note must be provided referring to the appropriate City Standard drawing.
 - 23. Details sheets should contain only transportation details. Please remove Trash enclosure details.
 - 24. Please provide a letter of response for all comments given.
 - 25. Traffic Studies: See the Traffic Impact Study (TIS) thresholds. In general, a minimum combination of 100 vehicles entering and exiting in the peak hour warrants a Traffic Impact Study. Visit with Traffic Engineer for determination, and fill out a TIS Form that states whether one is warranted. In some cases, a trip generation may be requested for determination (Contact Matt Grush: mgrush@cabq.gov).
