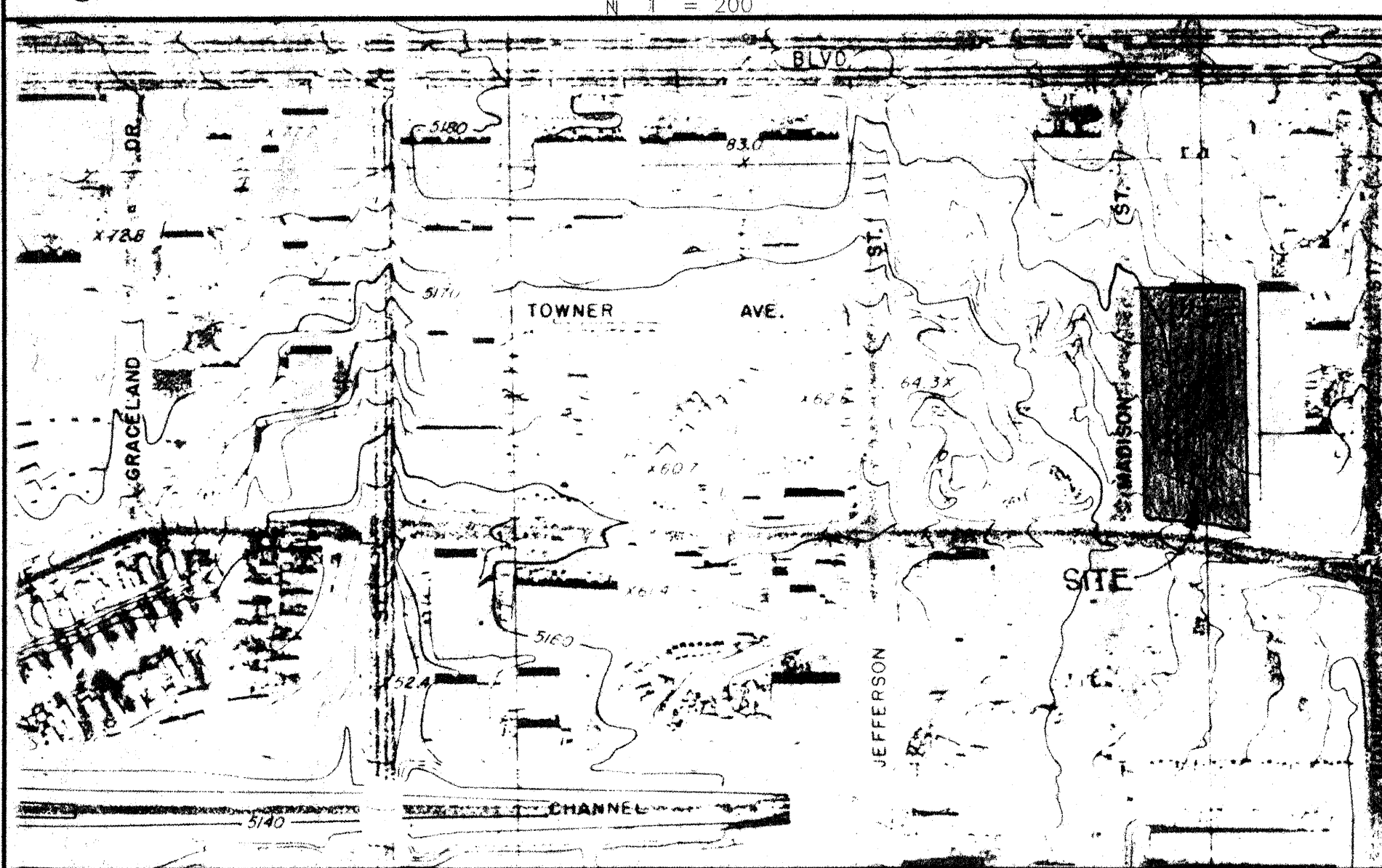

1. There is a flow increase of 0.57 and 0.62 cfs for the 10 year and 100 year storms respectively. The 6 hour runoff volumes for the two storms increase by 1193 and 1440 cubic feet.
2. A large portion of the site is presently developed. The proposed project will expand both the existing building and parking area. In addition portions of the existing asphalt parking will be removed to provide required landscaping. Concrete curbs will be constructed on both the existing and the new parking areas to control drainage. All runoff from the site will be directed through concrete drive pads to existing public streets.
4. The site is not located in a designated flood hazard area per FEMA FIRM Panel No. 352, dated September 20, 1996. The site does not contribute to an existing flood hazard area.
5. As shown on the offsite drainage map, there is no offsite drainage entering the subject site.
6. Topography shown on this sheet was obtained by Sandia Land Surveying in March, 1997.

4. THE CONTRACTOR SHALL VERIFY THE HORIZONTAL AND VERTICAL LOCATIONS OF ALL POTENTIAL OBSTRUCTIONS. SHOULD A CONFLICT EXIST, THE CONTRACTOR SHALL NOTIFY THE ENGINEER SO THAT THE CONFLICT CAN BE RESOLVED WITH A MINIMUM AMOUNT OF DELAY.

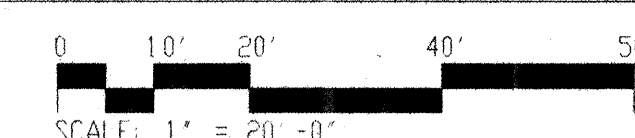
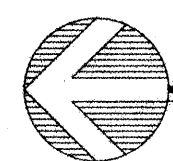
