AN ORDINANCE VACATING THE NORTHERLY 17 FT. OF INDIAN SCHOOL ROAD NE BETWEEN LOUISLANA BOULEVARD & ESPANOLA STREET, AND DECLARING AN EMERGENCY.

MMEREAS, there has heretofore been dedicated and conveyed to the Cley of Albuquerque, New Hexico a certain essement for street purposes, more particularly described below, and

WHEREAS, said right of way is not needed for public use except for essements reserved in Section 2 hereof,

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE, NEW MEXICO:

SECTION 1. The following described right of way is hereby closed and vacated subject to essements reserved in Section 2 hereof:

The north 17 ft. of Indian School Road NE between the east right of way line of Louisiana Boulevard and the west right of way line of Espanola Street as shown on Paving District No. 134, dated January 30, 1961.

SECTION 2. The City hereby reserves essements for public utilities, whether municipally or privately comed, which may be necessary for public use and benefit at the present time or in the future.

SECTION 3. Immediately upon the effective date of this ordinance, the land abovedescribed shall be effectively vacated, subject to essements reserved in Section 2 hereof, and the City of Albuque que by this ordinance disclaims from such date any further interest therein.

SECTION 4. This ordinance is an emergency measure due to urgent public need and will be effective five days after publication in full in accordance with law.].
