The USFWS Species Report and IPaC Critical Habitat Map indicate there are no critical habitats in the action area. The nearest critical habitat is approximately 5.8 miles southwest of the project. The species is not likely to be adversely impacted as the project's discharge enters the COA MS4 and must travel over six miles before meeting a natural watercourse. The watercourse further intersects with city irrigation canals, lengthening the distance discharge must travel before it would intersect with the habitat.
