

Please find the attached original grading and drainage plan and the revision (rfi 56). Due to existing utilities on site the invert of the sd pipe had to drop from 28 to 25.96. The previous design had a retaining wall, with the change in elevation we are now proposing a concrete slope blanket and the pipe mitered to the slope instead of the retaining wall.

We are hoping to as built this and show it on the as built certification, but since there is an SO-19 the inspector may say something due to the change from the originally approved Grading and Drainage Plan.

Let me know your thoughts at your earliest convenience, as always the contractor is on hold until this issue is resolved.
