1. Since this project is adjacent to, or drains into an Albuquerque Metropolitan Arroyo and Flood Control Authority (AMAFCA) facility, approval by AMAFCA will be need prior to Hydrology approval. Please contact Jared Romero P.E, CFM ([jromero@amafca.org](mailto:jromero@amafca.org) or 505-884-2215).
2. Per the DPM, the following must be on the Grading Plan. Please note the Grading Plan must be a stand-alone construction document.
  - a. Please provide a Vicinity Map. This can be downloaded in pdf format from the City of Albuquerque's website.
  - b. Please provide the FIRM Map and flood plain note with effective date.
3. Please add a note on the Grading Plan to reference the Drainage Report for details related to the project conditions, requirements, and calculations.

As a reminder, if the project total area of disturbance (including the staging area and any work within the adjacent Right-of-Way) is 1 acre or more, then an Erosion and Sediment Control (ESC) Plan and Owner's certified Notice of Intent (NOI) is required to be submitted to the Stormwater Quality Engineer (Doug Hughes, PE, [jhughes@cabq.gov](mailto:jhughes@cabq.gov), 924-3420) 14 days prior to any earth disturbance
