
Based upon the information provided in your submittal received 10-1-24, the above referenced plan cannot be approved for Building Permit until the following comments are addressed:

- Show detailed calculations of the number of parking spaces required by the IDO as well as the proposed number of parking spaces including bicycle and motorcycle parking. Specify the area sqft for each type of use and required parking spaces. Also, specify the details of Mullti-family Dwelling (# of BRs). Specify details for % reductions in parking spaces.
 - 2. Please list the width and length for all existing and proposed parking spaces. Some dimensions are not shown. Identify the texts on parking stall (S, SS, SC, C). There are 11 EV spaces on the plan, but the table indicates 50 spaces?
 - 3. Label the compact parking spaces by placing the words "**COMPACT**" on the pavement of each space.

- 4. ADA curb ramps must be updated to current standards and have truncated domes installed.
 - 5. Bicycle parking spaces shall be at least 6 feet long and 2 feet wide. Revise your details to reflect the spacing.
