The corresponding NOI was certified on 6/29/2020 and active on 7/13/2020. The corresponding NOI selected Criterion C as there are no critical habitats within one mile of the project. This is supported by the USFWS Species Report and IPaC Critical Habitat map. The nearest critical habitat is approximately 1.7 miles east of the project, point - to - point. However, the noted receiving water runs parallel to the critical habitat and does not appear to intersect with it for an extended distance.
