1. Please show a vicinity map showing the location of the development in relation to streets and well known landmarks. A Zone Atlas Page provided but no map shown location.

- 3. Slate Ave Frontage: Sidewalk adjacent to Existig Building shows stairs on public sidewalk. Why?
- 4. The turn radius at corner of 3rd/Slate is not consistent with AGIS please verify the corner radius versus the survey data.

5. Please identify all existing buildings, doors, structures, sidewalks, curbs, drive pads, wall and anything that influences the parking and circulation on the site.

- 6. Identify all existing access easements and rights of way width dimensions.
- 7. Identify the right of way width, medians, curb cuts, and street widths on 3RD St and Slate.
- 8. Please list the width and length for all existing and proposed parking spaces. Some dimensions are not shown (located on drive aisle off 3rd St).
- 9. The minimum parking stall dimensions are:

- 10. The ADA accessible spaces must include an access aisle. Van accessible aisles should be 8ft wide; all others should be 5ft wide. You can't use public sidewalk as an accessible aisle.
- 11. The ADA accessible parking sign must have the required language per 66-7-352.4C NMSA 1978 "Violators Are Subject to a Fine and/or Towing." Please call out detail and location of signs.
- 12. The ADA access aisles shall have the words "NO PARKING" in capital letters, each of which shall be at least one foot high and at least two inches wide, placed at the rear of the parking space so as to be close to where an adjacent vehicle's rear tire would be placed. (66-1-4.1.B NMSA 1978)
- 13. ADA curb ramps must be updated to current standards and have truncated domes installed. Verify the existing ramp at corner of 3rd/Slate is current standards.
- 14. Verify the existing drivepads off 3rd and Slate are current ADA accessible. If not replace and provide details and/or reference COA std dwgs.
- 15. Motorcycle parking spaces shall be designated by its own conspicuously posted upright sign, either free-standing or wall mounted per the zoning code.Label pavement MC.
- 16. All bicycle racks shall be designed according to the following guidelines:
 - a. The rack shall be a minimum 30 inches tall and 18 inches wide.
 - b. The bicycle frame shall be supported horizontally at two or more places. Comb/toaster racks are not allowed.
 - c. The rack shall be designed to support the bicycle in an upright position. See the IDO for additional information.
 - d. The rack allows varying bicycle frame sizes and styles to be attached.
 - e. The user is not required to lift the bicycle onto the bicycle rack.
 - f. Each bicycle parking space is accessible without moving another bicycle.
- 17. Bicycle racks shall be sturdy and anchored to a concrete pad.
- 18. A 1-foot clear zone around the bicycle parking stall shall be provided.
- 19. Bicycle parking spaces shall be at least 6 feet long and 2 feet wide.
- 20. Show all drive aisle widths and radii. Some dimensions are not shown.
- 21. The minimum drive aisle dimensions are shown below

- Per the DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the public sidewalk to the building entrances. Please clearly show this pathway and provide details.
- Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the ADA parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.
- ADA accessible pedestrian pathway should not be placed behind parking space or adjacent to a vehicular way. Vehicle and pedestrian/wheel chair conflicts should be avoided as much as possible.
- Provide a copy of refuse approval.
- 26. A Fire 1 approved plan from FD will need to be provided.
- It is not apparent what type of pavement surface is being proposed. A hard driving surface will be required as part of this proposed project for parking area and drive aisles.
- All one-way drives shall have "One Way" and "Do Not Enter" signage and pavement 28. markings. Please show detail and location of posted signs and striping.
- 29. A QUEUING ANALYSIS WILL TO DETERMINE APPROPRIATE DRIVE THRU LANE LENGTH.

The minimum drive through lane width is 12 feet with a 25 foot minimum radius (inside 30.

edge) for all turns. (A 15 foot radius can be used with an increase in lane width to 14 feet). Please dimension all lane widths and radii.

- 31. Please provide a sight distance exhibit
- Show the clear sight triangle and add the following note to the plan: "Landscaping and 32. signage will not interfere with clear sight requirements. Therefore, signs, walls, trees, and shrubbery between 3 and 8 feet tall (as measured from the gutter pan) will not be acceptable in the clear sight triangle.
- 33. Please specify the City Standard Drawing Number when applicable.
- Shared Site access: driveways that straddle property lines, or are entirely on one 34. propertybut are to be used by another property, shall have an access easement. Please include a copy of your shared access agreement with the adjacent property owner.
- Add a note stating "All broken or cracked sidewalk must be replaced with sidewalk and curb & gutter." A build note must be provided referring to the appropriate City Standard drawing (2430 & 2415A).
- 36. Please provide a letter of response for all comments given.
- Traffic Studies: See the Traffic Impact Study (TIS) thresholds. In general, a minimum 37. combination of 100 vehicles entering and exiting in the peak hour warrants a Traffic Impact Study. Visit with Traffic Engineer for determination, and fill out a TIS Form that states whether one is warranted. In some cases, a trip generation may be requested for determination (Contact Matt Grush: mgrush@cabq.gov).
