1. Listed are the number of parking spaces required by the IDO as well as the proposed number of parking spaces including bicycle and motorcycle parking. Coordinate/discuss with Zoning. **Status of Motorcycle Parkings(Explain)?**

2. Street name on Site Plan will need to be provided.

- 3. In accordance to AGIS, A sidewalk easement will be needed for sidewalk and curb & gutter located on private property. Please address this concern of property line location on AGIS versus Site Plan. Site has a 10' set back from existing curb.
- 4. Driveway entrance will need to be ADA complains. A construction note to remove and replace driveway with new needs to be added to Keyed Notes and the new width provided.
  - COA STD DWG 2525A (drivepad detail) is acceptable since it demonstrates ADA compliance across the drive pad entrance.
- 5. Keyed Note 6: shown on drive aisle! What is going on? Explain Projection of 2 dwelling units above parking, 9'-1" clearance.
- 6. Keyed Note 25: Explain this note because if you need a mini work order by Water Authority to can be done with a note added.
  - Note removed, if it's necessary, a mini work order for any water/sewer it can be obtained from Water Authority.
- 7. Site Plan: shown on plan are 3 bumper symbols on parking stall. Please address. Erased from site plan.
- 8. Identify the street width and ROW width on Sigma Chi Road.

30' wide and 60' R.O.W. added to plan

9. The minimum parking stall dimensions are: Motorcycle parking added on site plan

10. The ADA accessible spaces must include an access aisle. Van accessible aisles should be 8ft wide (you have provided only 7'-8"); all others should be 5ft wide.

11. **Motorcycle parking spaces (Status?)** shall be designated by its own conspicuously posted upright sign, either free-standing or wall mounted per the zoning code. Label **pavement MC**.

Motorcycle parking spaces added on site plan and sign noted and shown on plan.

12. Per the IDO, a 6 ft. wide ADA accessible pedestrian pathway is required from the public sidewalk to the building entrances. Please clearly show this pathway and provide details.

13. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the ADA parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.

14. Curbing should be installed to delineate landscape, parking, and pedestrian ways and identify points of access. Please call out detail and location of barrier curb.

In the area, parking and sidewalks are at the same ground level of public sidewalks, curbs will be only required for landscaping areas.

15. Please specify the City Standard Drawing Number when applicable.

16. Add a note stating "All broken or cracked sidewalk must be replaced with sidewalk and curb & gutter." A build note must be provided referring to the appropriate City Standard drawing (2430 & 2415A).
