Based upon the information provided in your submittal received 3-25-04, the above referenced plan cannot be approved for Building Permit until the following comments are addressed:

- 1. Please show the location of the nearest driveway on the adjacent lot.
- 2. List the width of the existing drivepads.
- 3. What is the current condition of the site?
- 4. Please show the vehicle path along the western property line, and call out the width of the vehicle path in this area.
- 5. The parking spaces along the northern property line must be 20 feet in width.
- 6. List the address of the site.
- 7. Please include 2 copies of the traffic circulation layout at the next submittal.
- 8. List the number of parking spaces required by the zoning code as well as the proposed number of parking spaces.
- 9. Where are the wheelchair ramps located? Please show them and provide details.
- 10. Call out the width of the striped pavement sections located parallel to the parking spaces.
- 11. Is the 12 foot clear area north of the proposed building blocked to prevent traffic from using this area?

- 12. List the number of handicapped accessible parking spaces required, and show the location of these spaces.
- 13. Please list the width and length for all parking spaces.
- 14. Define the width of the proposed sidewalk.
- 15. A 5 foot keyway is required for dead-end parking aisles.
