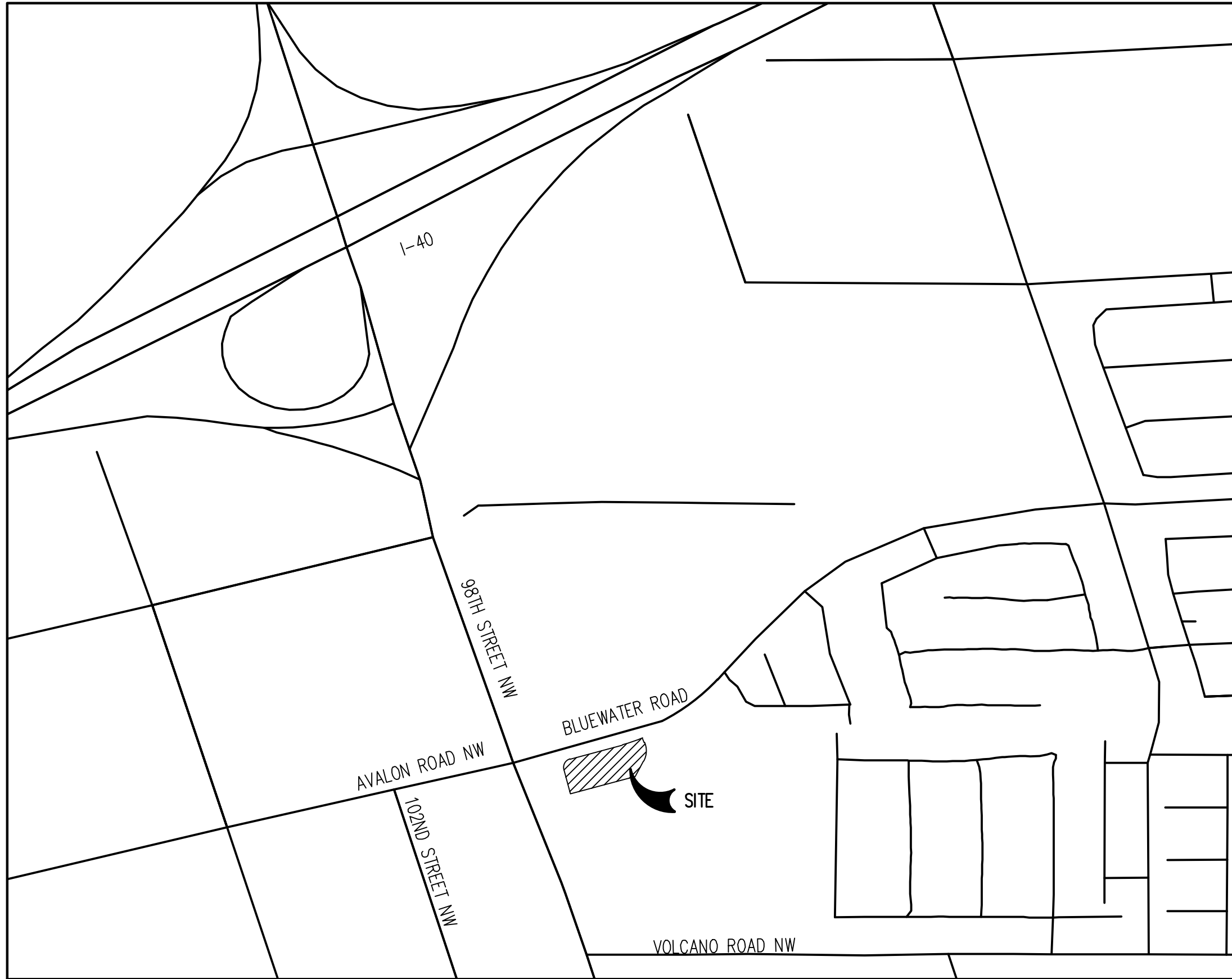

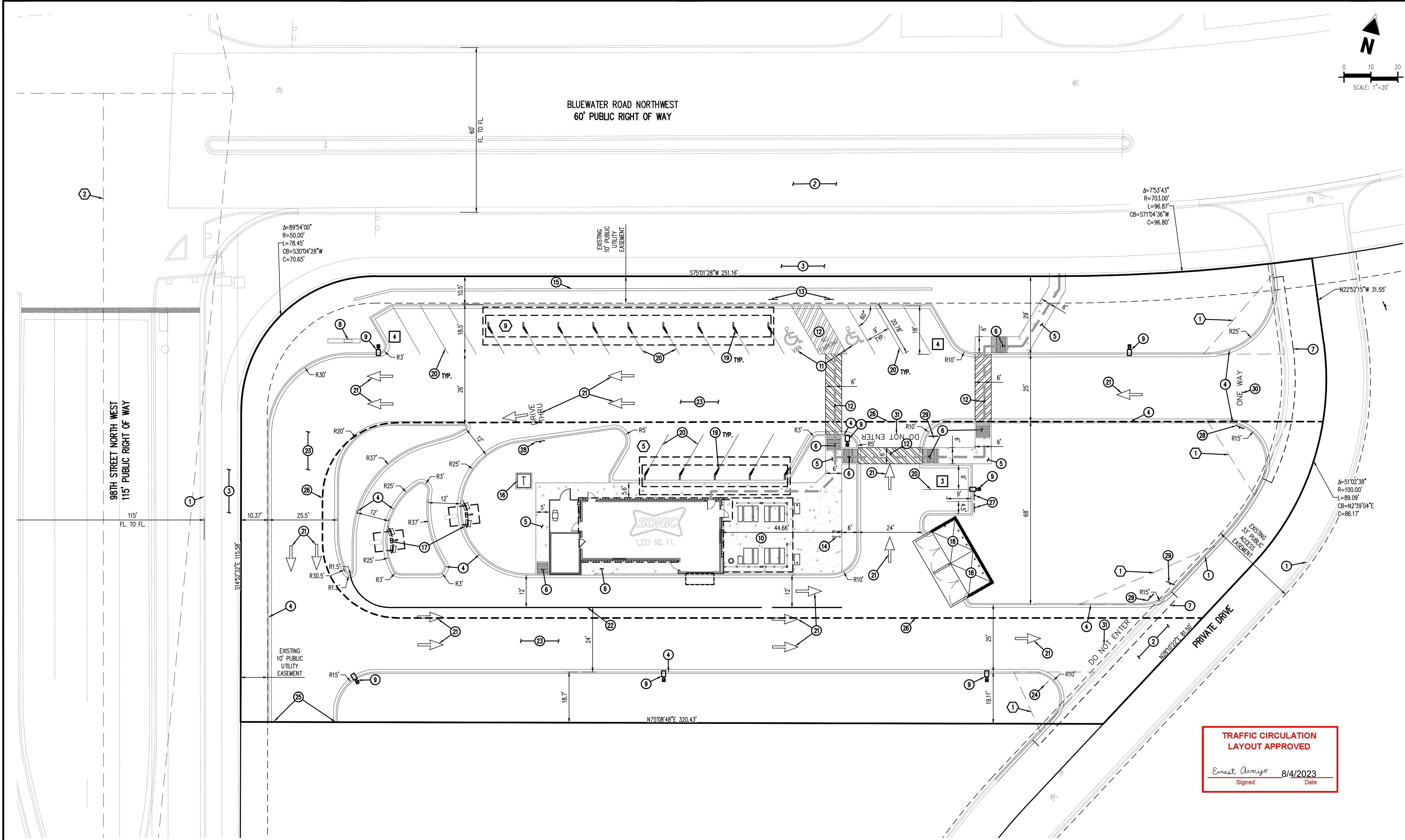

SIGHT TRIANGLES

1. **CORNER SIGHT TRIANGLE:** SHOWN AT EACH INTERSECTION. CORNER TRIANGLES SHALL HAVE A 30' LEG LOCATED AT THE EDGE OF EACH STREET FLOWLINE AND A 30' LEG LOCATED IN THE INTERSECTING STREET'S FLOWLINE. CORNER TRIANGLES SHALL BE FREE OF ALL ITEMS OVER 30" IN HEIGHT EXCEPT FOR TRAFFIC CONTROL DEVICES AND EQUIPMENT.

2. **AASHTO SIGHT TRIANGLE:** PLACE ONE LEG OF THE TRIANGLE IN THE CENTER OF THE EXIT LANE OF THE DRIVEWAY OR INTERSECTING STREET 18' BACK OF THE EDGE OF TRAVELED WAY AND THE OTHER LEG'S LENGTH SHOULD BE PER AASHTO GUIDELINES FOR DEPARTURE TRIANGLES AND LOCATED IN THE CENTER OF THE APPROACHING LANE. NO ITEMS THAT ARE WIDER THAN 18 INCHES MAY BE TALLER THAN 30" WITHIN THIS TRIANGLE EXCEPT FOR STREET TREES AND TRAFFIC CONTROL DEVICES AND EQUIPMENT.
