Provide a brief summary of the basis for criterion selection listed above (the necessary content for a supportive basis statement is provided under the criterion you selected.):

The corresponding NOI was certified on 2/4/2021 with anticipated authorization on 2/18/2021. The USFWS Species Report and IPaC Critical Habitat Map indicate the nearest species is approximately 1.91 miles east of the project, point - to - point. The source documents indicate there are no endangered species in the project action area. It is not likely the nearest species or habitat will be adversely impacted by the project activities as the first receiving water is a soft - bottomed channel which runs parallel to the habitat without intersecting for over five miles. The project area is in an arid area which is unlikely to produce precipitation to cause enough precipitous flow to carry and pollutants from the project through the MS4 system to the Rio Grande where the habitat exists.
