USFWS Species Report and IPaC Critical Habitat Mapper confirm there are no critical habitats or endangered/threatened species in the action area. The nearest threatened species is an aviary species and not subject to physical boundaries. However, it is unlikely the species will be adversely impacted by the project work as it does not provide the preferred wooded habitat for the species. Additionally, the noted receiving water does not discharge to the critical habitat as it feeds to a large stormwater detention pond which has no outlet.
