Good morning Debra,

For your attached Administrative Amendment (AA) application at 401 Alvarado, before we can accept and process it and distribute it for staff review we need to determine if an AA application approval is necessary in the first place. In your justification letter you mention that no existing site plan is on record. If that is the case, then you will not have to go through an AA as there must be an original Site Plan approval from the Environmental Planning Commission (EPC) and/or the Development Review Board (DRB) to amend in the first place for an AA to be approved. If no Site Plan governs the site, you will just need to apply for the necessary permits through Building Safety and possibly a Traffic Circulation Layout (TCL) for altering the existing parking lot into a playground and Grading and Drainage Plan if necessary for your proposed development. I have copied Misa Bloom, the File Room Coordinator for the Planning Department, in this message to confirm if she can find an EPC and/or DRB-approved Site Plan per the following approvals I found on the site:

- 1. ZA-84-86
- 2. ZA-78-430
