

The TCL submittal, dated September 9, 2002, is sufficient for acceptance by this office and is stamped and signed as such. One copy was kept for this office's files. Two will be needed for submittal of building permit plans, and one is to be kept by you to be used for certification of the site for final C.O. for Hydrology/Transportation.

At the time of the call by the superintendent, for a Temporary C.O. (Temp) (if a Temp is desired), he will be informed to contact designer-of-record to Certify for the Temp C.O. Barricading will be required clearly separating vehicles and pedestrians from unfinished work, as applicable.






