The USFWS Species Report and IPaC Critical Habitat map indicate there are not critical habitats or endangered species in the action area. The nearest habitat is approximately 2.6 miles west of the project and supports the Rio Grande Silvery Minnow. It is unlikely the project discharge will adversely impact the habitat and species as the discharge must travel through three municipal channels, approximately 6.4 miles, prior to meeting the habitat. During that travel there are various divergences which could direct the discharge away from the habitat.
