The photos show the application of seeding and hydraulic mulch. The photos were taken on May 16, 2022 and May 4, 2022. The entire site falls under the semi - arid/arid exception for final stabilization. The photos show the exposed soils are covered and supplemented with silt fence, where it does not cause a safety concern. The project retains silt fence along Girard Blvd. and Gibson Blvd. in addition to pre-existing landscaping. The silt fence on the east and southern perimeters were removed as the silt fence causes a safety concern for the neighboring airport runway.
