The following are City Hydrology's comments on your grading permit request. Given that this grading permit request is for a borrow pit for the Sunport project, which is not typical of development grading permit requests, I solicited comments from Loren Mainz for EPA requirements.


- The contractor must file a "Notice of Intent" (NOI) for construction activity with E.P.A. and must have an appropriate pollution prevention plan. See typical details in the Sunport Construction Plans for level of detail expected. The pollution prevention plan must address on-site disiltation ponds and must be maintained during construction and after construction until the vegetation has established. (NOI application attached).
- Provide existing and proposed ortho-topo map with horizontal and vertical control.
- Provide construction schedule for the borrow pit operation and the anticipated completion of final grading.
- Include with your resubmittal the calculations for the identified flow rates.
- Follow Section 1012 of the City Standard Specification and/or specific requirements addressed in the Topsoil Disturbance Permit.
- Coordinate with and address concerns of all City, County, State and Federal Agencies involved with the Sunport Project and provide confirmation that such has been done.
