Dear Mr. Coleman,

Failure to provide self-inspection reports when requested to do so on 8/1/2019 and 8/8/2019 is an ordinance violation. The latest report that we have received is dated 6/6/2019. CGP Standard Permit Conditions I.8 and I.9 require reports to be furnished upon request. Reports are required every 14 days and after each rain of 0.25" or more.

Required Mitigation:

Provide the requested self-inspection reports.

If the violations are not mitigated within 7 days, the property owner is subject to a fine of \$500/day per the City's Drainage Control Ordinance.
