Re: Ceja Vista Development Traffic Impact Assessment (PWTR2018-0009)

Dear Mr. Brown,

Bernalillo County issued a letter on October 25, 2019 approving the final Ceja Vista TIA dated August 25, 2019. The final TIA approval was based on several conditions. On January 30, 2020 we met with you and Mr. Bill Allen to discuss the conditions of approval. This letter clarifies Bernalillo County requirements for the Ceja Vista development based on the January 30, 2020 discussion.

Bernalillo County sees the need to ensure connectivity between Ceja Vista and the surrounding road network. This was not provided in detail in the final TIA. For this reason, this letter lists these requirements.

- 1. Future Connection:
  - <u>Near-Term Meade Rd.</u> Ceja Vista will provide a minor collector road connection to the Meade Rd and Karrol Rd (Grace Vigil Rd) intersection. See Attachment 1. Minor collector roadways standard ROW is 60 ft. encompassing 5 ft. wide sidewalks on both sides of the road and paved shoulders/bicycle lanes. Residential driveways will be permitted to individually directly access this minor collector.
  - <u>Mid-Term Connection to APS Atrisco Heritage High School/George I. Sanchez</u> These points are for information purposes. See Attachment 1.
    - $\circ$  Ceja Vista Phase 2 internal road network provides a connection to APS Atrisco Heritage High School.
    - Ceja Vista Phase 2 includes a proposed future school site. Internal Phase 2 roadways connect to this site and do not inhibit a future connection to Borrega Rd. to the east.

- Long-Term Connection west to 118<sup>th</sup> St. This point is for information purposes. See Attachment 1. Bernalillo County is seeking a future major collector connection west to 118<sup>th</sup> St. This connection involves collaboration with property owners west of Ceja Vista. The future Phase 3 or future Phase 4 of Ceja Vista can allow for connections west to the internal Ceja Vista network. Currently the Phase 3 and Phase 4 road network has not been planned.
- <u>Long-Term Connections South</u> As the Ceja Vista site develops further south in Bernalillo County the following connections are required:

 $\circ$  Unser Blvd connection to Gun Club Rd. as a community principal arterial (standard ROW is 120 ft.)

- 98<sup>th</sup> St. connection to Gun Club Rd. The current proposed right-of-way for 98<sup>th</sup> St from Unser Blvd continuing south is 60 ft. wide which meets the standard right-of-way for a minor collector. The current special use permit phase 2 shows a proposed neighborhood commercial and county regional park adjacent to 98<sup>th</sup> St. As these proposed land uses develop along with phase 4, 98<sup>th</sup> St. shall be evaluated to see if a major collector designation is more appropriate. Standard rightof-way for a major collector is 74 ft. wide.
- Recommendations for NM 500 and Condershire Dr. Finally, improvements to this intersection will be shared by Bernalillo County, Ceja Vista, and Sunrise Village.

Bernalillo County requires a "fair share" negotiation for this intersection. Currently, Bernalillo County is working on a 30% design for the intersection to gain a better understanding of costs. Attachment 2 provides information on the proportion of trips generated by Ceja Vista and Sunrise Village.


