Dear Ms. Ruiz,

The subject Traffic Impact Study received on October 13, 2021, has been reviewed by the City. The following comments are to be addressed satisfactorily before final approval by the City of Albuquerque Planning Development Transportation Section.

The turn lane recommendations are broken down by the project phase, major traffic contributor, and feasibility of being constructed within existing right of way/physical space within the roadway cross-section. The size of the turn lane will be based on the COA DPM requirements.

The major traffic contributors are identified as either Montage (west of University/south of Bobby Foster), Netflix (east of University), or Bernalillo County Athletic Fields (west of University/north of Bobby Foster). The feasibility was determined in the Albuquerque Studios Master Plan Development TIS.

Intersection #5 University Boulevard and Eastman Drive/Bobby Foster is yet to be determined as to the intersection configuration and control.
